Agreement for residence in 4-H House for the semester beginning (September)
(February) 1960.

1. I, the undersigned student, agree to accept and retain the room assigned to me by 4-H House, located at 202 East Green Street, Champaign, Illinois.
2. I agree to pay the sum of Fifty-Nine Dollars (\$59.00) per month for the term of the semester stated above, payable on or before the 10th of each month. I agree to a penalty of \$0.05 the first day and \$0.02 every day thereafter if not paid within the time stated above.
3. I agree that under either of the circumstances listed below, I shall be responsible for one-half of the unpaid balance of this contract:
 - a. If I withdraw from the University of Illinois at any time during the semester for reasons other than illness or physical disability.
 - b. If I do not continue to reside at 4-H House for the stated semester but remain enrolled in the University of Illinois.
4. If I am away from the house to complete my educational requirements or because of illness or physical disability for a period of four weeks or more, I shall be responsible for no more than one-half of the sum stated above for the period of my absence.
5. ~~Four-H House agrees to make available a room for the undersigned student for the stated semester, and agrees to operate and maintain its home in compliance with the University of Illinois standards for approved student homes.~~
6. Four-H House reserves the right to cancel this contract if it shall deem necessary to do so; however, it shall make a refund of any amount paid for any part of any month or semester remaining hereunder.
7. This contract shall be binding upon 4-H House when a signed copy is received by the Assistant Treasurer at the address below, together with a deposit of Ten Dollars (10.00) on or before (July 1) (December 20).
8. This contract may be cancelled by the undersigned student if written notice is received by the Assistant Treasurer on or before (August 1) (February 1). No refund of the deposit shall be made after said date.
